ORDER 20-12

AN ORDER RATIFYING AND LEVYING AD VALOREM TAXES FOR COUNTY FUNDS FOR THE 2020-2021 FISCAL YEAR AND FOR EACH YEAR THEREAFTER UNTIL OTHERWISE PROVIDED; DIRECTING THE ASSESSMENT AND COLLECTION THEREOF;

WHEREAS, the Commissioner's Court of Parker County, Texas finds the tax for the year 2020-2021, hereinafter levied for current expenses of the 2020-2021 fiscal year for Parker County and the general improvement of the County and its property must be levied to provide the revenue requirements of the budget for said fiscal year; and

WHEREAS, the Commissioner's Court of Parker County, Texas further finds the tax for the year 2020-2021 hereinafter levied is necessary to pay the interest and to provide the required sinking fund on bonds of the County that have been or will be issued for County purposes, and on debt incurred for such purposes.

NOW, THEREFORE BE IT ORDERED BY THE COMMISSIONERS COURT OF PARKER COUNTY, TEXAS, that for the current expenses of the 2020-2021 fiscal year of Parker County and the general improvements of the County and its property, there is hereby LEVIED and ORDERED on all property situated within the limits of said Parker County and not exempt from taxation by valid laws or by order of the Commissioners Court of Parker County, Texas a General Fund Ad valorem tax rate of \$0.204791 (.204791 CENTS) on the \$100.00 assessed valuation of such property.

BE IT FURTHER ORDERED BY THE COMMISSIONERS COURT OF PARKER COUNTY, TEXAS that for current expenses of 2020-2021 fiscal year

of Parker County for improvements to roads and bridges, there is hereby LEVIED and ORDERED to be assessed and collected for the 2020-2021 fiscal year and for each year thereafter until it be otherwise provided and ordered, on all property situated within the limits of said Parker County and not exempt from taxation by valid laws or by order of the Commissioners Court of Parker County, Texas a Lateral Road Fund Ad Valorem tax rate of \$0.073952 (.073952 CENTS).

BE IT FURTHER ORDERED BY THE COMMISSIONERS COURT OF PARKER COUNTY, TEXAS that for the purpose of paying interest and providing the required sinking fund for bonds of the County issued for County purposes, there is hereby LEVIED and ORDERED to be assessed and collected for the 2020-2021 fiscal year and for each year thereafter until it be otherwise provided and ordered, on all property situated within the limits of Parker County and not exempt from taxation by valid laws or by order of the Commissioners Court of Parker County, Texas, a General Fund Ad Valorem tax rate \$0.079876 (.079876 CENTS), on the \$100.00 assessed valuation on such property and a Lateral Road Fund Ad Valorem tax rate of \$0.0000 on the \$100.00 assessed valuation on such property; and

This budget will raise more total property taxes than last year's budget by \$2,454,968 or 4.8% (\$473,757 for the Lateral Road and Bridge Fund, \$2,687,404 for Debt Service and a \$706,193 decrease for the General Fund Maintenance and Operations). Of that amount \$2,183,807 or 89% is tax revenue to be raised from new property added to the tax roll this year.


BE IT FURTHER ORDERED BY THE COMMISSIONERS COURT OF PARKER COUNTY 2020-2021 LEVIED hereby and herein and ORDERED to be assessed and collected on all property situated within the limits of Parker County and not exempt from taxation by valid law or by the order of Commissioners Court of Parker County, Texas is \$0.358619 on the \$100.00 valuation of such property.


