The Texas Supreme Court signed an Order Requiring Electronic Filing In Certain Courts on December 11, 2012. This order mandates electronic filing (e-filing) in civil cases, including family and probate cases, by attorneys in appellate courts, district courts, statutory county courts, constitutional county courts, and statutory probate courts pursuant to a detailed implementation schedule.
